**SUPPLEMENTAL CERTIFICATE OF SERVICE**

In compliance with the *Order Granting Debtors' Amended Motion for Entry of an Order (i) Authorizing Debtors to File a Consolidated Creditor Matrix, and (ii) Granting Authority to Establish the Master Service List Applicable to these Cases* [Dkt. # 65] (the "Notice Order"), the *Order Granting Debtors' Amended Motion to Approve Website Notice Procedures* [Dkt. # 70] (the "Website Notice Order"), and Local Bankruptcy Rule 2002-1, the undersigned states the following:

**PREVIOUS SERVICE**

1. As reflected in the *Certificate of Service* filed on September 28, 2017 [Dkt. # 213] pertaining to the Debtor's *Motion to Dismiss GRP of Zanesville, LLC, Case No. 17-11445-SAH* [Dkt. # 201] (the "Motion to Dismiss Zanesville"), Counsel for the Debtors caused notice of the posting of the Motion to Dismiss Zanesville to the parties on the Matrix attached to the Certificate of Service (Exhibit "1," attached hereto) on September 14, 2017.

2. In advance of the hearing on the Motion to Dismiss Zanesville scheduled for October 18, 2017, Counsel for Debtor reviewed the September 14, 2017 service in anticipation of submitting a proposed Order and realized that the Matrix was a prior version of the Matrix and was missing addressees. Accordingly, Counsel for Debtor filed an application to continue [Dkt.

# 217], notifying the Court of the notice deficiency. This Court granted that application on October 17, 2017 [Dkt. # 218].

### SUPPLEMENTAL SERVICE

3. Counsel for Debtor identified the parties that were on the Amended Consolidated Matrix [Dkt. # 116] that were not included on the September 14, 2017 Matrix (Ex. 1) and therefore did not receive proper notice from the September 14, 2017 service. Counsel for Debtor then created a Supplemental Matrix (Exhibit “2,” attached hereto) of those parties on the Amended Consolidated Matrix that were left off the prior mailing.

4. On October 20, 2017, Counsel for Debtor mailed full pleading copies of the Motion to Dismiss Zanesville,<sup>2</sup> by U.S. Mail, postage pre-paid, to the Supplemental Matrix along with a *Notice of (i) Motion to Dismiss GRP of Zanesville, LLC; (ii) Amended Fee Application of D.R. Payne & Associates; and (iii) Amended First Interim Fee Application of Crowe & Dunlevy; Notice of Opportunity for Hearing; and Notice of Hearing* (Exhibit “3,” attached hereto) (the “Supplemental Notice”). The Supplemental Notice explained the circumstances that led to the previous deficient service, provided notice of the twenty-one-day deadline to file a written response or objection, and informed the recipient that if no response or objection was filed the Court could grant relief without a hearing. Additional proof of service of the Supplemental Notice and the Motion to Dismiss Zanesville on behalf of Copy Scan & More is attached as Exhibit “4.”

5. Furthermore, on October 20, 2017, the entire Amended Consolidated Matrix—comprised of the parties from the September 14, 2017 service and the Supplemental Matrix—

was sent notice of the *Order Granting Application to Continue Hearing on (i) Motion to Dismiss Zanesville, LLC; (ii) Amended Fee Application of D.R. Payne & Associates; and (iii) Amended First Interim Fee Application of Crowe & Dunlevy* [Dkt. # 218], in which every party on the Amended Consolidated Matrix received notice of the continued hearing date and the deficiency relating to the service of the Motion to Dismiss Zanesville and the two fee applications which led to the continuance.


