**ORDER AUTHORIZING EMPLOYMENT OF
BANKRUPTCY FINANCIAL ADVISORS
[Pertains to the Motion at Dkt. No. 13]**

Upon the application of Eateries, Inc. and GRP of Zanesville, LLC (collectively, “Debtors”), for authority to employ David R. Payne, CPA, CIRA, CTP, ASA, ABV, CDBV and other financial managers, consultants and staff of D.R. Payne & Associates, Inc. (hereafter, collectively, “DRPA”), as financial advisors for the Debtors (Dkt. No. 13), and upon the Affidavit of David R. Payne (Dkt. No. 14), and the court being satisfied that they represent no

interest adverse to the Debtors as debtors-in-possession herein, or their estates, in the matters upon which they are to be engaged, that their employment is necessary and would be in the best interest of the estates, and that the cases are ones justifying as a cost of administration payment to such professionals for their services rendered to the debtors-in-possession in normal hourly fees charged, reimbursement and expenses incurred, and such additional compensation as the court may approve, it is hereby

ORDERED that Debtors be and are hereby authorized to employ the firm of DRPA to represent them as debtors-in-possession in the captioned case; and to perform financial advisory services for Debtors upon the terms stated in the Application;

AND FURTHER ORDERED that such fees shall be paid as a cost of administration at the normal hourly fees charged by each respective accountant, including reimbursement of expenses and such additional compensation as this Court may approve upon notice and opportunity for hearing and pursuant to such procedures as may be fixed by order of this Court.

All findings of fact are based upon representations of counsel (Local Rule 9013(i)(1)).
