**RESPONSE OF THE UNITED STATES TRUSTEE TO THE DEBTOR’S  
AMENDED MOTION FOR ENTRY OF AN ORDER (I) AUTHORIZING THE  
DEBTORS TO FILE A CONSOLIDATED CREDITOR MATRIX AND (II) GRANTING  
AUTHORITY TO ESTABLISH THE MASTER SERVICE LIST APPLICABLE TO  
THESE CASES AND NOTICE AND OPPORTUNITY FOR HEARING  
[Docket #30]**

The United States Trustee (“UST”) files this response to the Debtor’s Amended Motion for Entry of an Order (I) Authorizing the Debtors to File a Consolidated Creditor Matrix and (II) Granting Authority to Establish the Master Service List Applicable to These Cases and Notice and Opportunity for Hearing (Docket #30). In support of this response, the UST states:

1. Although the Debtor has not filed its schedules or statement of financial affairs<sup>2</sup> the representations in the Affidavit of William C. Liedtke, III (Docket #10) as well as representations made by Debtor’s counsel to the UST appear sufficient at this time to determine the reasonableness of the Debtor’s request.
2. Based on said representations, the UST has no objection to the Debtor’s request except that the respective state taxing and regulatory authorities for each state in which the Debtor does business should be added to the Master Service List.

WHEREFORE, based on the foregoing the UST has no objection to the Debtor’s request as presented.
